



How to prepare for submitting an application to the NT Nominee Program's Employer Driven Stream

Step 5: Start the application process - this step is only available once the NT Nominee Program (NTNP) re-opens in February 2025:

- a) Go to the NTNP online application portal: <https://ntnp.immigratenwt.ca/>
- b) Nominating Employers must register on the NTNP online portal by creating a unique Employer User ID for each nominee's application. Should they have multiple nominees, Employers can use the same name, phone number and email address each time they register but **they must always use a different User ID.**
- c) Once registered, Employers log into the online application portal and select 'Start an application.'
- d) Employers then choose the program category they want to apply to and review the mandatory eligibility criteria.
- e) The Employer then completes the Employer Application Form, which includes a tab to attach the required documents, and then presses submit to complete the first part of the application.
- f) The Foreign National Submission Form will then become available and the foreign national completes this form, including a tab to upload required documents, and then presses submit to complete the application.
- g) When both forms have been completed and submitted, the Employer will receive a confirmation email that includes the file number and the application is placed in the intake queue.
- h) For fairness and consistency, all applications to the NTNP will be processed in the order they were received by date.

Important Application Submission Tips

- All required fields of information must be completed, and all required documentation must be submitted.
- Employers may save an application at any stage and return to it later to complete.
- Applications cannot be submitted until all the required information and documents are attached to the application. The system will not accept an application until it is fully completed.
- If a section on the Employer or Nominee Applicant forms does not apply, please write 'not applicable' or 'N/A'.
- Employers can contact NTNP staff by email at immigration@gov.nt.ca if they need assistance in using the online application portal.
- Once a form has been submitted it is locked and cannot be edited. Any requests for edits can be made by emailing the NTNP at immigration@gov.nt.ca. Program staff can make the edits on the back end of the application portal.
